

NOTICE INVITING BIDS
BOULDER CREEK SEWER INTERCEPTOR PROJECT - PHASE I
(Job No. 2225)
BID SCHEDULE NO. 4313

In accordance with the Municipal Code of the City of Redding, sealed bids will be received at the office of the City Clerk, 777 Cypress Avenue, Redding, CA 96001, until 3 p.m., Tuesday, March 9, 2010, at which time they will be publicly opened and read for the performing of the work as follows:

Work of the project includes construction of approximately 6,273 feet of new sanitary sewer interceptor ranging in size from 18-inch to 28-inch in diameter to replace the existing sanitary sewer interceptor. Project includes approximately 3,319 feet of open cut new alignment construction, 2,571 feet of trenchless replace-in-place construction, 17 new 48-inch manholes, 2 new 72-inch manholes, and approximately 3 manhole modifications to accommodate trenchless construction and reconnection of existing lateral connections. Exact quantities may vary slightly depending on Contractor's lateral connections. Exact quantities may vary slightly depending on Contractor's selected method of construction in accordance with these specifications.

The Engineer's Estimate is \$2,398,000.

The Contractor shall possess a Class A license at the time bid is opened.

A prebid conference is scheduled between staff and interested bidders at 1 p.m. on February 24, 2010, in the River Conference Room at 777 Cypress Avenue, Redding, at which time the project and the requirements of the funding program will be reviewed. A field trip over/through the proposed site will be conducted following the meeting. All bidders are encouraged to attend.

Each bid shall be made in accordance with the specifications and proposal requirements thereof and no bid will be received unless it is made on a proposal form furnished by the City Engineer. Each bid must be accompanied by cash, certified or cashier's check, or original bidder's bond made payable to the City of Redding for an amount equal to at least ten percent (10%) of the total amount of the bid as a guarantee that the contractor will execute the contract in conformance with his proposal and the specifications. Such guarantee shall be forfeited should the bidder to whom the contract is awarded fail to enter into the contract.

The City of Redding hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

The Disadvantaged Business Enterprise (DBE) goal for this project is 15.47 percent.

This is a Federally assisted project. The general prevailing rate of per diem wages, holidays, and overtime work for each craft, classification, or type of workmen needed to execute the contract are established by the Secretary of Labor in accordance with the Davis-Bacon and are located in the specifications and can be found at <http://www.gpo.gov/davisbacon/>. The American Recovery and Reinvestment Act (ARRA) requirements apply to this project. In addition, the general prevailing rate of per diem wages, holidays, and overtime work for each craft, classification, or type of workmen needed to execute the contract are established by the State of California, Department of Industrial Relations, and are on file in the office of the City Clerk, City of Redding. If there is a difference between the minimum wage rate determined by the Secretary of Labor and the prevailing wage determined by the State of California for similar classifications of labor, the higher wage rate shall prevail. Contractors shall not pay wages less often than once per week.

Funding for this project has been provided in full or in part through an agreement with the State Water Resources Control Board. The contents of this document do not necessarily reflect the views and policies of the State Water Resources Control Board, nor does mention of trade names or commercial products constitute endorsement or recommendation for use.

The envelope enclosing the proposal shall have stated thereon, "Boulder Creek Sewer Interceptor Project - Phase I, (Bid Schedule No.4313)."
