

2010 REPLACE AC SURFACING PROJECT

In accordance with the Municipal Code of the City of Redding, sealed bids will be received at the office of the City Clerk, 777 Cypress Avenue, Redding, CA 96001, until 3 p.m., Thursday, April 15, 2010, at which time they will be publicly opened and read for the performing of the work as follows:

Street surface preparation, approximately 67,600 cubic feet of replace AC surfacing, traffic control, striping, pavement marking, and all other work shown on the drawings and as required by the specifications at various locations in the City of Redding.

The Engineer's Estimate is \$520,000.

The Contractor shall possess a Class A or C-12 license at the time bid is opened.

Each bid shall be made in accordance with the specifications and proposal requirements thereof and no bid will be received unless it is made on a proposal form furnished by the City Engineer. Each bid must be accompanied by cash, certified or cashier's check, or original bidder's bond made payable to the City of Redding for an amount equal to at least ten percent (10%) of the total amount of the bid as a guarantee that the contractor will execute the contract in conformance with his proposal and the specifications. Such guarantee shall be forfeited should the bidder to whom the contract is awarded fail to enter into the contract.

The City of Redding hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

The general prevailing rate of per diem wages, holidays, and overtime work for each craft, classification, or type of workmen needed to execute the contract are established by the State of California, Department of Industrial Relations and are available on their internet web site at www.dir.ca.gov/DLSR/PWD, and are on file with the City of Redding.

Copies of referenced Standard Specifications for Public Works Construction, commonly called the "Greenbook," 2009 Edition containing the General Provisions and Standard Technical Specifications may be obtained from Building News, Inc., 1612 South Clementine Street, Anaheim, CA 92802 (714) 517-0970.

No bid will be accepted from a contractor who is not licensed in accordance with the provisions of California Business and Professions Code Sections 7,000 et seq. and regulations adopted by the Contractors' State Licensing Board, as amended. The envelope enclosing the proposal shall have stated thereon, "2010 Replace AC Surfacing Project, (Bid Schedule No. 4318)."

The City Council of the City of Redding reserves the right to accept or reject any and/or all bids and to make that award which is in the best interest of the City.
